## **Wholesale commission:**

- 10% of each order amount.

# Rules and Regulations.

Healthy Habits® reserves the right to add amend or delete any of the following Rules and Regulations with out notice.

1. A Distributor pays \$49.95 for a semi annual Membership. The cost of the Membership will be automatically charged on the 6 month anniversary of the Distributors activation.
2. Only a Distributor can sponsor someone. Non-Distributors may refer customers to Healthy Habits® but they will not earn commission, bonuses or any compensation.
3. You must maintain your Distributor Membership to receive commission and bonuses. There are no retroactive commissions or bonuses. If your Distributor status is not active you will not receive compensation. It is the sole responsibility of the Distributor to maintain their Distributor Membership.
4. Personal websites are not permitted to display the name or registered trademarks of Healthy Habits® its products, associated brands or symbols. Violation will result in immediate termination.
5. Use of unsolicited email for commercial purposes (SPAM) is strictly prohibited.
  - a. Posting advertisement to online newsgroups, forums, blogs etc, is strictly prohibited.
  - b. Online resale of Healthy Habits® products must adhere to current MAP agreements. MAP violations will result in immediate termination.
6. Healthy Habits® Distributors do not have exclusive territory.
7. It is the sole responsibility of the Distributor to provide their Distributor ID# to all referrals.
  - a. Your referral must mention your Distributor ID# when placing their first order.
  - b. Sponsors will not be changed or reversed once an application on order has been submitted.
  - c. Distributors may not change sponsors. Distributorship is limited to one per household or mailing address.
  - d. New Distributors are strongly encouraged to confirm their Distributor status BEFORE referring any customers

# Policies and Procedures

Healthy Habits® reserves the right to add amend or delete any of the following policies or procedures with out notice.

1. Advertising and use of trademarks.
  - a. A Healthy Habits® Distributor is not allowed to advertise Healthy Habits® products or marketing plans unless written approval has been obtained by the Company. Pre approved and company produced materials may be used at any time.
  - b. A cancelled, terminated or resigned Distributor must immediately discontinue use of the Healthy Habits® business name, trademarks, printed material and symbols.
  - c. Distributors must have written approval prior to engaging in internet, radio or television advertising of Healthy Habits® products.
  - d. Failure to comply with these policies will result in immediate termination.
2. Commission and Bonus Payments.
  - a. Commission and bonuses earned shall be paid by check between the 1<sup>st</sup> and 10<sup>th</sup> day of the month following the month in which commission and or bonus was earned.
  - b. Discrepancies and errors must be reported immediately. Distributors are encouraged to monitor their commission and bonus activity online at the Distributor back office.
  - c. Only orders bearing the Distributors ID# as the Sponsor will be included in the monthly statement used to calculate commission and bonus if eligible.
  - d. Any bonus paid on a returned item will be debited from the Distributors Bonus and Commissions. In the event that returned items are greater than the commission and bonus earned, the negative balance will be deducted from the Distributors credit card on file.
  - e. Commission and bonuses are paid on the amount of product sold on the invoice, excluding tax, shipping and any applicable surcharges.
3. Cancellation, Termination or Death of Distributor.
  - a. Terminated Distributors may not be reinstated. Any commission or bonus due at the time of termination will be forfeited.
  - b. Terminated Distributors down-line will be transferred to Healthy Habits® immediately.
  - c. In the event of death or incapacity, a Distributors membership may transfer to the person appointed by the Distributor as legal beneficiary.
  - d. Cancelled Distributor memberships may be reinstated.
  - e. Healthy Habits® reserves the right to terminate a Distributor Membership at any time for any reason.
4. Disputes.

  - c. Products returned beyond the 90 day guarantee period will be subject to a 20% restocking fee and will not be eligible for refund. Product credit will be issued in the adjusted return amount.

6. Product pricing
  - a. Healthy Habits® reserves the right to change prices of its products on printed material and on any website held by Healthy Habits® at any time without notice.
  - b. Sale prices will have an accompanying coupon code. The coupon code must be used at the time the order is placed. Coupon codes may not be used past the printed expiration date.
  - c. Coupon codes may not be combined with any other coupon code or special offer.
  - d. Shipping/freight and handling fees are not included in product pricing unless otherwise specified.
  - e. Wholesale pricing is available to Distributors who order in case quantity with the intent to resell the product. Distributors who resell Healthy Habits® products must provide a signed copy of the Healthy Habits® MAP agreement. MAP violations will result in immediate termination. Wholesale price list and MAP agreement are available to active Distributors only upon request. Wholesale prices are subject to change without notice.
  - f. Distributors who intend on reselling Healthy Habits® products online must first obtain permission and provide internet addresses for all online sales sites.
7. Transfer or sale of Distributorship.
  - a. Distributorship may be sold or transferred upon receipt and approval of buyer or transferees distributor application. A one time Distributor transfer fee of \$250.00 will be collected in addition to the semi annual Distributor fee of \$49.95.
  - b. Pre-approval is suggested before any sale or transfer. Healthy Habits® reserves the right to deny any sale or transfer for any reason.
8. Waiver.
  - a. In the event that Healthy Habits® does not exercise its rights in a seemingly appropriate time frame, it shall constitute waiver of rights to act. Only a written notice from the CEO of Healthy Habits® shall constitute waiver of rights to pursue a matter.
